# Live At Home Solutions

## Fee Schedule for Contractors/Handymen

Application Fee: \$20

The Application Fee is a one-time fee payable at the time of application to become a Participating Provider

The Application Fee will be waived for Providers who sign a Participating Provider Agreement within 90 days of Dec. 1, 2009.

Contractors/Handymen will pay a \$10 per month monthly participation fee.

Providers may pay the participation fee in advance by the month, quarter, or year. Providers who pay for a full year (12 months) in one payment will receive the 13<sup>th</sup> month free of charge.

In addition, the monthly participation fee will be waived for the first three months of the initial agreement period for providers who agree to devote at least 3 hours serving on a designated Provider Association Task Force or Committee. The purpose of this service is to help develop, promote, and improve Live At Home Solutions.

Contractors/Handymen who provide seasonal services can pay a participation fee on a month-by-month basis during the months when you provide a particular service.
